Reporting in the PQRS program can be done using one of several reporting methods, including claims-based data submission.

The Physician Quality Reporting System (PQRS) is the quality reporting program under Medicare Part B. Eligible professionals, including physical therapists who bill PQRS is a voluntary reporting program that provides a financial incentive for certain health care professionals, including psychologists, who participate in Medicare

Physicians who cannot identify nine individual PQRS measures for 2015 can make up the difference by reporting Your How-To Guide for Ophthalmology.

CMS is aligning the PQRS (PQRI) and Meaningful Use programs, but they must add more measures for certain specialties, like podiatry.
